Dania Plans To Rebuild City Marina



The City of Dania Beach's marina will be improved later this year with the addition of new and additional dock space, a new harbor master building and other facilities.

The City of Dania Beach's 92-slip marina, located behind Florida Atlantic University's SeaTec complex and across the parking lot from Dania Beach Pier, is about to get a \$4.9 million face lift to become one of the leading passive marina facilities in South Florida.

The plywood boards overlaying the weathered wooden planks are coming out. Pilings are being replaced. New floating docks put in. A new harbor master building will be built, a pavilion erected, as well as four fish cleaning stations and bar-be-que grills installed around the docks.

"It absolutely will be a state-of-the-art facility," said Tyler Chappell, a principal in the The Chappell Group, an environmental consulting firm in Fort Lauderdale, and a member of Dania Beach's Marine Advisory Board.

Ideas collected from Dania Beach residents on the city's marine advisory board and the company managing the marina, as well as visits to other South Florida marinas by representatives from the Chappell Group, the engineering firm of Craven Thompson and the architectural firm ACA resulted in the design and engineering of the city's proposed marina.

Construction is scheduled to start in

August 2012. In the meantime, The Chappell Group is obtaining environmental permits from federal, state and Broward County agencies.

The marina, located at 101 N. Beach Road, currently has a harbor master house that is shared with Dania Beach's lifeguards. A chipped concreted pad fronts the marina, which is entered through a black metal security gate.

When bids were accepted in 2010 for a management company to operate the marina, it was noted the marina was is disrepair, and required improvements to receive the rents that the city wanted for the 42 fixed and 50 floating dock slips. Westrec Marina Management, was selected to manage the marina. Dock space costs \$350 per month for floating dock space, and \$575 per month for permanent dock space. Up to 50foot boats drawing from four to six feet can be accommodated by the marina. Last year, the Dania Beach City Commission agreed to undertake improvements to the marina, which will be partially funded with county

The marina is accessed by water from the Intracoastal Canal by crossing under a bridge with an 18-foot clearance spanning the entrance to John U. Lloyd State Park, or by land from the parking lot at the city's beach. No fuel is sold or boat overhauls are

Deputy Lacertosa Runs Ironman Challenge

A year and a half ago a Dania Beach resident, BSO Deputy Tina Lacertosa, ran the Boston Marathon and at the time, she said she was thinking about participating in an ironman chal-

Lacertosa, 32, completed the ironman in Panama City on November 5,

The ironman competition consists of a 2.4 mile swim, then a 112 mile bike ride, and then a 26.2 mile run. She completed the Ironman in 11 hours, 42 minutes.

Lacertosa attended elementary and middle schools in Hollywood and Dania and then graduated from St. Thomas Aquinas High School and the University of Maryland where she played soccer.

She trained for the Ironman event for six months and followed a nutritional regimen of eating healthy foods that would give her stamina.

Some days she would swim for an hour and then run for two hours. Other days she would bike ride for three hours and then run for hours. She trained everv day for two to five hours a day.

"Training became my whole life," said Lacertosa, "I had no social life because between working and training. I was so tired."

The ironman competition was also a mental challenge.

"After completing the swimming and bike riding leg, you would still have to complete a marathon," said Lacertosa, "So thinking positive was also

Quarterdeck Restaurant Considered For Pier

The Quarterdeck, a well-known South Florida restaurant chain, has made an offer to the City of Dania Beach to operate the restaurant on Dania Beach Pier under its brand name and employ 85 to 95 people.

In late December, Paul Flanigan, the chain's owner, was the only person to respond to the city's letter of interest to operate the pier restaurant.

'The (Dania Beach City) Commission has directed me to begin negotiating with Mr. Flanigan," said Dania Beach City Attorney Tom Ansboro. "The five restaurants that he has, he owns. He's never leased before. But I am confident we are going to make the deal happen because it's Continued On Page 4



"I have social security and retirement and this just isn't the time in my life to risk getting hurt anymore," Tarrant said.



"And of course my wife Connie is right there with her list of things for me to do," Tarrant laughed, "so my free time fills up pretty fast."





Another challenge is protecting sea grass growing in the marina tidal basin during and after construction.

"Sea grass is a protected species and is considered essential for fish habitats," Chappell said.

The marina also will be Americans

With Disabilities Act compliant, meaning that people using wheelchairs, walkers and other assisted devices will be able to access the marina and docks. It will be one of the only marinas in South Florida that meets this criteria.

"This has been a great project," Chappell said. "The team meshed well and came up with a design that the city really likes. It will tie in nicely with the beach master plan and the pier."
